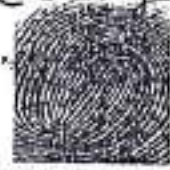

3. President

- (b) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and /or maintaining and /or running institutions, centers, auditoriums and the like for the running of welfare and other services to the public and to provide meeting room for socially useful activities and functions.
- (c) To establish Orphanages, old age homes, Widow homes, lunatic asylums, or other establishments for relief and /or destitutes.
- (d) To give, provide and /or render food medicine and other help and/or assistance in any shape or form to the poor deserving and needy persons especially the economically weaker sections of the society.
- (e) To give, provide and/or render monetary and /or other help and assistance for the relief of persons and animals affected by natural and other calamities such as flood, fire, famine, cyclone, earth-quake, storm, accident, drought, epidemic, to give donations, subscriptions doing relief work on such occasions.
- (f) To promote, advance and encourage and /or aid in helping, promoting, advancing and encouraging primary, secondary including technical and medical education also physical training, training of handicrafts, fine art and other useful arts, crafts among the public including the establishment and maintenance of Kala Kendras and other welfare centers for them.
- (g) To encourage education and training in handicrafts, fine arts among people in general and establish and found institutions imparting such education and to establish, maintain, support or help by monetary gifts or otherwise, centers and institutions for women and children and to provide social welfare works for women and children.
- (h) To grant, pay or give scholarship, stipends, prizes, rewards, allowance and other financial assistance or help in cash or kind to students with a view to help them in pursuing their studies in schools, colleges, educational institutions, technical institutions, art schools, institutions teaching commercial and other arts.

- (j) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and /or maintaining and /or running by monetary gift or otherwise, centers, stadium, play grounds and parks for public use, sports and games and other social welfare works and/or activities.
- (k) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up establishment, maintenance and/or running Dharamsalas.
- (l) To promote, organize, administer, support, maintain, and/or grant aid to any person, institution, or society or organization whatsoever having for its objects of charitable purposes and to incur expenditure in connection therewith.
- (m) To promote, assist and/or maintain all activities by whatsoever carried on or wherever on in India in conformity with the objects of the Trust.
- (n) To assist economically in the rehabilitation of the poor & needy women & provide them free/ concessional food, shelter, education & to arrange their marriage.
- (o) To financially & otherwise assist the government/semi-government/ other charitable/ social establishment/ organization in eradication of Polio, AIDS, Cancer, Hepatitis B & other critical illness for building a healthy & strong nation.

6. Enabling Powers

That for the furtherance of the objects of the trust, the trustees shall have the following powers:

- (a) To accept any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, Institutions, State or Central Government, Government Departments, Local Authorities, etc. with or without conditions.

- (b) To apply the whole or any part of the income of the trust, or the accumulations thereto, to any one or more of the objects of the trust, as they may, in their discretion, deem fit from time to time.
- (c) To convert and deal with the trust property and/or any investments for the time being.
- (d) To invest trust Fund either in the purpose of mortgage of immovable property, shares, stock or debentures or other securities and investments, or in deposits, loans to any company, bank, firm or any other person, and to alter, vary or such investments, from time to time at the discretion of the Life Trustees.
- (e) To borrow or raise or secure payments of moneys and also to lend money with or without security.
- (f) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- (g) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Life Trustees in their discretion may think fit.
- (h) To open account in the name of the Trust, and Institutions run/ conducted by Banks, and to operate such account and to give instructions to the President, Secretary and Treasurer, however the President can further authorize any officer/employee of the Trust to operate the account.
- (i) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- (j) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or run any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.

- (k) To appoint or make provisions for the appointment of any person (including all or any of the Life Trustees and committees or administrator or Managing Trustees or any of the Life Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Managing Committee may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this deed in such manner and subject to such rules and regulations as the Managing Committee may from time to time think fit.
- (l) To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- (m) To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.
- (n) To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects and/or provide aid by way of donations out of the income or the corpus of the Trust Fund or otherwise to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purpose mentioned in these presents or any of them to enable such institution, societies, organization or Trustees to start maintain, or carry out such charitable objects.
- (o) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.

10. Meeting

Meetings of the managing Committee shall be held at least four times in a year. However with the consent of President, at any time meeting can be called upon. Meeting of General Body shall be held once a year of the Trustee in which Annual Audited Accounts shall be produced with Annual Report. All life trustees shall be entitled to vote and attend the meeting. However all the powers are vested in Managing Committee.

11. Period of Notice

Notice period shall be minimum of 7 days. However it can be reduced on the event of any emergency, with the consent of President.

12. Quorum

Presence of 2/3 members of the Managing Committee shall be quorum. In case present members are less than 2/3, the meeting shall be adjourned for the next week on the same day, same place and same time, for which no quorum shall be required.

13. Duties & Rights of Managing Committee

- To put new proposals/ project & take decisions in opening of Educational Institution/ Hospital and for other charitable activities etc.
- Preparation of Budget.
- Approval of Expenses.
- Approval of Income & Expenditure Account, Balance Sheet and Auditor's Report thereon.

- e) Modification of constitution of the trust.
- f) To appoint Auditors.
- g) Managing Committee shall have right to form sub committee for any institution (s) in which all the members of Managing Committee shall be the member of sub committee and additional members so far opted from outside shall have no voting rights but they can provide their opinion to run the institution and shall participate the meeting.

14. President

- a) Sri Amit Tandon shall be the first President.
- b) Sri Amit Tandon the first president shall nominate his successor and he shall reserve the right to change such nomination during his lifetime.
- c) The president of the Trust shall always be having right to nominate his/her successor.
- d) The nominated person, if found minor at the time occupying the chair, then a Trustee having longest tenure shall be appointed as an Acting President till the attaining the age of majority of such Minor.
- e) The President shall have power to appoint any trustee in the Managing Committee.

15. Rights & duties of President

- a) The President shall have option to nominate two persons as successor, and if first nominated person refuses to accept or otherwise, then such opportunity shall be given to second nominated person and in case of the second person also refusing to accept or otherwise, then the person selected by the Managing trustee shall be appointed as the President.
- b) The president shall be the Principal Officer of the Trust.
- c) The President shall have right to take any decision in the interest of the trust.
- d) The President shall preside the meeting of managing Committee and in his absence Vice- President shall preside the meeting.

- e) Account of Trust can be opened in any scheduled Bank/Post Office by the President jointly with Secretary and Treasurer but such Account (s) shall be operated by any two persons out of the President, Secretary and Treasurer.
- f) The President shall have the right to receive donations, corpus fund, etc. for and on behalf of the trust.
- g) The President's decision in any dispute will be final and binding on all.
- h) The President shall nominate the Vice- President/ Manager/ Asst. Treasurer etc.
- i) The President shall be empowered for Modification and/or alteration to the object and bye-laws of the Trust, in the interest of Trust.
16. Vice - President
In the absence of President, he/she will act as a President.
17. Rights & Duties of Secretary
- a) Secretary shall operate and execute all workings of the trust.
- b) He/she will keep and maintain minutes books of the meeting and will issue notice of meetings.
- c) He/she will keep and maintain members register of the trust.
- d) He/she will carry on all the working of the trust on the instructions of the President.
- e) He/she will operate Bank account jointly with President or Treasurer.
- f) He/ she will keep and maintain all the funds, securities, deeds which are the property of the trust in safe under his/ her custody and he/she will be responsible for all such properties.
18. Manager
- 1) Manager will act as secretary in the absence of the Secretary.
- 2) He/ she can do undertake any other responsibility of the Managing Committee duly authorized by the President.

22. The number of the Managing Committee shall not be less than two and more than Five. If the number of the Managing Committee shall fall below two, the Treasurer shall not, except for the purpose of filling any vacancy, act so long till the number is below the said minimum.
23. The Managing Trustee for the time being will be at liberty to appoint additional trustee within the number mentioned above for such period or on such terms as to retirement and re- appointment as the trustees for the time being consider proper.
24. Every Trustee will be at liberty to resign on giving one month's notice of his/her Intention to do so.
25. The Managing Committee may from time to time frame rules for the conduct and regulations of the meetings of trustees. In
- All matters will be decided mutually by the Managing Committee.
 - Resolution passed without any meeting of the Managing Committee but by circulation thereof and evidenced in writing under the hands of one thirds of the trustees including President shall be as valid and effectual as a Resolution, duly passed at a meeting of Managing Committee.

31. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.
